MEETING NOTICE – PUBLIC WORKS COMMITTEE Tuesday July 24th 2012 – 6:00 P.M. – Council Chambers – City Hall

ITEMS TO BE DISCUSSED AND ACTED UPON:

1. Call to order/Roll Call
2. Certification of the open meeting law agenda requirements and approval of the agenda
3. APPROVAL – Minutes of the May 29th 2012 meeting
4. DISCUSSION AND ACTION – Community Sensitive Design (CSD) proposals for the Marquette Road Project (NOTE: This is the preliminary presentation and discussion of the amenities, landscaping and other related visual items related to the project, including what the look of the roundabouts is being proposed. A Public Informational Meeting will be held in August to review the proposals with the public. The Committee will then meet again in August or September to finalize the CSD component.)
5. DISCUSSION AND ACTION – Wells Street Sidewalk Project (NOTE: At the May 29th Committee meeting, the following motions were approved: 1) to place staff action on moving forward with the December 2011 motion to install sidewalk on the south side of Wells Street, from 18th Street to 20th Street, on hold for sixty (60) days, 2) to direct staff to develop a plan for installing sidewalks on the south side of Wells Street from 14th Street to 19th Street, and 3) to direct staff to develop a plan for installing sidewalks on the west side of Fremont Street from Wells Street to Taylor Street. A spreadsheet showing projected costs is included in the packet.)
6. DISCUSSION AND ACTION - Authorization to bid the roof replacement on the WWTF administration and blower buildings (NOTE: These would be bid on one document with the blower building being an "alternate" bid.)
7. DISCUSSION AND ACTION - Authorization to bid sanitary manhole rehabilitation for 2012 (NOTE: This is included in the 2012 budget. Staff is seeking approval to expend up to \$20,000 for this work.)
8. DISCUSSION AND ACTION - Authorization to bid sanitary sewer lining. (NOTE: This is for the sewer line in the alley between Illinois and Michigan St, from Iowa to Wisconsin Street. This work would be done in 2012.)
9. ADJOURNMENT
