C. PUBLIC WORKS – Request from Blair Dillman to Vacate a Portion of Fisher and Roulette Streets on St. Feriole Island – The Committee recommended the Council approve removing a portion of Fisher Street, from its intersection from Water Street to a point twenty (20) feet east of the railroad crossing, and Roulette Street, from its intersection from Water Street to a point twenty (20) feet east of the most easterly

railroad track, but not to proceed with the project unless the Wisconsin Southern Railroad (WSOR) approves the proposed project Dillman has for that area of St. Feriole Island, and the project not to commence until the proposed project is underway.

D. PUBLIC WORKS – Proposed Ordinance Amending Chapter 7.06 (17) (North and South Illinois Street) - The purpose of this Ordinance (2015-10) is allow traffic on South Illinois Street from Webster Street to Cass Street to be two way, and prohibit parking on either side on South Illinois Street from Webster Street to Cass Street. If approved, the change would take effect October 5th 2015.

A. DISCUSSION AND ACTION – Review and Action on Contract Amendment #1 for PDC Project #1661-05-26 between the City of Prairie du Chien and CORRE

The purpose of this amendment is to extend the date for completion of appraisals from 9/30/2015 to 10/30/2015 and to include additional appraisals and their costs. These changes are the result of modifications to the real estate plat and of the real estate process. Any additional costs incurred will be reimbursed by the Wisconsin Department of Transportation.

B. DISCUSSION AND ACTION – TIF Assistance (Nelson True Value)

Nelson True Value is seeking \$4,000 in assistance from TID #4 (the new store falls within one-half mile of the TID) to construct a conduit around the fiber optic line which runs alongside the property, which the city assisted in moving earlier this year. This project would considerably assist with the projected opening date of November 25th. Staff would recommend approval of the request.
