REPEALING AND RECREATING CHAPTER 7.06 (17) (NORTH AND SOUTH ILLINOIS AVENUE) OF THE MUNICIPAL CODE OF THE CITY OF PRAIRIE DU CHIEN, CRAWFORD COUNTY, WISCONSIN

Purpose: The purpose of this Ordinance is allow traffic on South Illinois Avenue from Webster Street to Cass Street to be two way, and prohibit parking on either side on South Illinois Avenue from Webster Street to Cass Street.

The Common Council of the City of Prairie du Chien, Crawford County, Wisconsin, does ordain as follows:

Section 1: That Chapter 7.06 (17) (North and South Illinois Avenue) of the Municipal Code of the City of Prairie du Chien, Wisconsin be repealed and re-created to read as follows:

(17) SOUTH ILLINOIS AVENUE.

- (a) Those portions of South Illinois Avenue from Taylor Street to Webster Street shall be designated two way traffic north and south.
- (b) Those portions of South Illinois Avenue from Webster Street to Cass Street shall be designated two way traffic north and south, and there shall be no parking on either side on South Illinois Avenue from Webster Street to Cass Street.
- (c) Those portions of South Illinois Avenue from Cass Street to Iowa Street shall be designated one-way vehicular traffic in a southerly direction.
- (d) Those portions of South Illinois Avenue from Iowa Street to Wisconsin Street shall be designated one-way vehicular traffic in a northerly direction.
- (e) Those portions of South Illinois Avenue from Wisconsin Street to Blackhawk Avenue shall be designated two way traffic north and south, and there shall be no parking on either side of South Illinois Avenue from Wisconsin Street to Blackhawk Avenue
- (f) Those portions of North Illinois Street from Blackhawk Avenue to Park Street shall be designated one-way vehicular traffic in a northerly direction.
- (g) Those portions of North Illinois Street from Park Street to Washington Street shall be designated one-way vehicular traffic in a southerly direction.
- (h) Those portions of North Illinois Street from Washington Street to McLeod Street shall be designated one-way vehicular traffic in a northerly direction.

Section 2: Any ordinance or parts thereof inconsistent herewith are hereby repealed.

Section 3: This Ordinance shall be effective on October 5th 2015.
